**Terms and conditions**  
**(numbers refer to each separate service type)**

1. Terminal handling charges include general handling and storage in warehouse, export and import cargo delivery to/from Customs bonded warehouse to/from the delivery area in the cargo terminal or to another area in the cargo terminal indicated by the terminal operator. Thru ULD handling requires a separate agreement between the handling parties. The charges apply separately for each part shipment (i.e. if the shipment arrives with 2 different flights, all charges are applied twice)
2. Shipments originating from a regulated agent will be charged as unknown if the transportation chain does not fulfil the requirements set by the local authority and current aviation security regulations. Removal of undeclared dangerous goods will be charged by the applicable hourly rate.
3. A free period of 48 hours, excluding the initial Saturday and/or Sunday and/or a public holiday, commences at 00:01 AM on the day following the day of arrival.

All storage charges are payable by the party nominated as the agent/consignee in the airwaybill. Liability of the carrier ends when the goods are delivered to the person entitled to delivery. If the shipment is forwarded, Finnair Cargo Oy disclaims any responsibility concerning the allocation of warehouse charges. Storage charges are also applied when the shipment is stopped irrespective of Finnair Cargo.

4. Charges concerning house air waybills (HAWB) will be charged on the master airwaybill (MAWB). If the MRN has been received by FWB/FHL messages or via web portal or the self-service computer available at our terminal customer service, no charge will be collected. If the MRN is entered by AY staff, the cost applies per MRN.
5. All shipment data should be sent either by using FWB/FHL messages or by entering the details in Finnair Cargo Online. In case discrepancies and/or data entry required by AY personnel, the charge applies. In case of Consolidation, the fee is applied per house air waybill (HAWB) and the charges concerning house air waybills (HAWB) will be charged on the master airwaybill (MAWB).
6. VAL charges are also applied to transit shipments (for both transportation from/to aircraft).
7. DGR charges are also applied to all rechecks. In case a shipment is rejected, the 2<sup>nd</sup> and any subsequent checks are charged double. There is a separate fee for both export and import.
8. Fee applies only for export shipments and is also applied to all rechecks. In case a shipment is rejected, the 2<sup>nd</sup> and any subsequent checks are charged double. The fee is applied per AWB (i.e. if the shipment consists of multiple special handling codes, the fee is charged once)
9. Fee applies for both export and import.
10. Fee applies for both export and import. After partition takes place within 24 hours from customer's request.
11. On customer's request.
12. On customer's request. Loading/offloading is performed by one cargo warehouse employee, if additional staff is required, the hourly rate of section 13 is applied. **Loading/unloading of heavy items (over 3000kg) needs to be separately agreed.**
13. On customer's request. For the hourly rate, minimum cost is one hour.
14. QDL needs to be ordered 24hrs before flight arrival and be **confirmed by AY personnel**. Confirmation is available 8 hours before flight arrival. Trucks are not included.
15. Fee applicable for all AY shipments with consolidations, irrespective of the origin of the shipment. Fee is per House Airwaybill.
16. Fee applicable for all Charges Correction Advices made for AY shipments, irrespective of the origin of the shipment.

**Per AWB means per MAWB/HAWB, whichever is applicable.**  
**All charges are subject to changes and stipulations without prior notice.**
